WHEREAS, on March 13, 2020, President Donald J. Trump issued a Proclamation Declaring a National Emergency Concerning the Novel Coronavirus Disease Outbreak;

WHEREAS, on March 13, 2020, Governor Henry McMaster declared a state of emergency throughout the State of South Carolina in response to the spread of Coronavirus Disease 2019 (COVID-19), pursuant to Executive Order No. 2020-08;

WHEREAS, on March 16, 2020, President Donald J. Trump announced that all Americans, including the young and healthy, should avoid gathering in groups of more than 10 people;

WHEREAS, on March 16, 2020, the Supreme Court of South Carolina issued a Memorandum to all Trial Courts postponing all jury trials and stating that non-jury trials and other hearings may continue at the trial judge's discretion;

WHEREAS, the Supreme Court of South Carolina further stated in the March 16, 2020 Memorandum that, to the extent possible and circumstances warrant, hearings that can be held by video may be held remotely;

WHEREAS, on March 19, 2020, Governor Henry McMaster directed that all non-essential employees and staff of the State of South Carolina shall not report to work, physically or in-person, effective Friday, March 20, 2020, and until further notice, pursuant to Executive Order No. 2020-11;

**WHEREAS**, by Order of the Supreme Court of South Carolina dated March 20, 2020, the public was no longer permitted access to the Supreme Court Building and the Calhoun Building;

WHEREAS, by Order of the Supreme Court of South Carolina dated March 20, 2020, incoming paper documents delivered to the South Carolina Supreme Court and the South Carolina Court of Appeals are subject to a 48-hour quarantine period once they are physically received by the Supreme Court or the Court of Appeals;

WHEREAS, COVID-19 represents an evolving public health threat, which requires that the Charleston County Probate Court continue to take all necessary actions to protect the health of the public and the health of court personnel and their families;

WHEREAS, pursuant to S.C. Code Ann. § 14-23-220, "[t]he probate court shall be deemed open at all times for the transaction of ordinary business which may be necessary, when previous notice is not required to be given to the persons interested";

WHEREAS, pursuant to S.C. Code Ann. § 14-23-230, "[a] probate court may be adjourned as occasion may require";

**NOW, THEREFORE** effective March 21, 2020, in order to protect the health of the public and the health of court personnel and their families, the Charleston County Probate Court will be closed until further Order of this Court.

The Charleston County Probate Court will continue to accept emergency filings. A drop-box will be located in the lobby of the Charleston County Judicial Center, located at 100 Broad Street, Charleston, South Carolina 29401, and any filings can be made via the drop-box at any time that the Judicial Center is accessible to the public. Emergency filings can also be scanned and electronically transmitted to the Court via email to James Ward (jward@charlestoncounty.org), so long as the original filing is sent immediately by U.S. Mail.

The Charleston County Probate staff will be working remotely and will continue to serve our citizens by phone, video conferencing, email, and texting.

The Charleston County Probate will continue to hold civil commitment hearings via video conferencing.

The Charleston County Probate Court will hear all emergency matters via video conferencing. All currently scheduled non-emergency matters are hereby cancelled.

Adult Drug Court, Juvenile Drug Court, Mental Health Court, and Veterans Treatment Court sessions are postponed pending further Order of this Court.

In the near future, marriage license applications will be completed online through the Charleston County Probate Court's Live Online Virtual E-Marriage Application (LOVE) system.
